## **PUBLIC NOTICE FOR TRAINING PARTNERS/INSTITUTES**

### **INCENTIVE SCHEME FOR BUILDING A POOL OF CSDCI-TOT CERTIFIED TRAINERS**

We express our appreciation for the valuable role you play in shaping the future workforce through your training programs. As the world continues to evolve, the need for skilled professionals who are equipped with latest knowledge and expertise has become more critical than ever before.

To encourage Training partners(TPs) to create an adequate number of Trainers to deliver Skill Development Programs at Speed and Scale, the following initiatives are taken by CSDCI:

**1.For Existing CSDCI Affiliated Training Partners or interested Training Partners who are currently working or wish to work on Skill Development Programs where CSDCI acts as project implementing Agency (PIA).**

The Training fee of **INR 11,000/Trainer**- will be reimbursed to Training Partners who create CSDCI TOT certified Trainers and utilize/engage these trainers in CSDCI implemented programs such as NIPUN, PMKVY and other such schemes as applicable.

The Time period within which the said reimbursement benefit can be availed is from 2<sup>nd</sup> march 2023 to 31<sup>st</sup> May 2023.

Terms and conditions for availing the said benefit:

- 1.Training Partners have to engage these trainers in above-mentioned schemes where CSDCI acts a Project Implementing Agency(PIA).
- 2.Certified Trainers should mandatorily work for a minimum of 6 months or program duration, whichever is earlier on said programs.
- 3.TPs have to submit the monitoring data in terms of Training conducted by said sponsored Trainer on a monthly basis to CSDCI.

**2.For Training Partners working with Project implementing Agency (PIA) other than CSDCI, the following initiatives are taken by CSDCI:**

The Amount of **RS 5000 /Trainer** will be reimbursed to those Training Partners who create CSDCI TOT certified Trainers and utilize/engage these Trainers in programs such as NIPUN, PMKVY and other such schemes as applicable.

The Time period within which the said reimbursement benefit can be availed is from 2<sup>nd</sup> march 2023 to 31<sup>st</sup> May 2023.

Terms and conditions for availing the said benefit:

- 1.PIAs shall be routing all their assessments through CSDCI
- 2.Certified Trainers should mandatorily work for a minimum 6 months or project duration, whichever is earlier, under said programs
3. TPs have to submit the monitoring data in terms of Training conducted by said sponsored Trainer on a monthly basis to CSDCI

Note-The Maximum limit of number of Trainers covered under this said incentive scheme shall be solely determined by CSDCI and can be modified at any time during the said validity period of this scheme.
